Profile of applicants:


Middle and higher-level managers working in systems partner operator organizations.

- 3. Curriculum vitae updated, indicating the degree of studies.
- 4. Motivation statement.
- 5. Letter of support granted by the Executives Directors of the systems partner operator organizations, which grants permission to be absent for the duration of this certificate (7 days) and commitment to cover the costs of air transportation and dinners.
- 6. Other requirements:
- Current passport and USA VISA.
- Advanced English language skills.
- At least 2 years of experience in the water sector.

Application, evaluation and selection of participants:

- A. The applicant's application will be in a personal and non-transferable capacity.
- B. The Potential beneficiaries to get a scholarship will be selected through an evaluation process coordinated by the ANEAS.
- C. The applications that fulfill the requirements mentioned in this call will be evaluated.
- D. The results will be announced through the Training Coordination of ANEAS.
